## <u>Health Screening and Vaccination Requirements for NUS Pharmacy Students (Cohort 2022</u> and onwards)

In accordance with the Singapore Ministry of Health requirements, students enrolled in a healthcare professional programme with direct patient contact or contact with patient specimens during clinical training must undergo the following health screening and meet these vaccination requirements:

## <u>Notes</u>

- 1. The above health screening and vaccination requirements are also applicable to selected Post-Graduate Pharmacy students who carry out research or clerkship activities at HCIs.
- 2. Students must bear the cost of the required health screening(s) and vaccination(s).
- All Students are encouraged to have their screening(s) and immunization(s) done between 8:30am to 10:30am or 1:30pm to 3:00pm (Mon to Fri) at the University Health Centre (UHC) at Level 1, 20 Lower Kent Ridge Road, Singapore 119080.
- 4. Students are to bring along their identification card, health booklets (for Singaporeans) or any other documentary proof of vaccination records and this copy of Health Screening and Vaccination Requirements upon registration at UHC for medical examination.
